

RATING RATIONALE

WCRCL has reaffirmed 'WCRSE 3' (pronounced as WASO Credit Rating Small Enterprise Three) rating under the SME Rating to Lowhajang

Enterprise (Hereinafter referred as "LE" or "The Enterprise") based on its financial and other relevant qualitative and quantitative information upto the date of the rating issuance.
