

RATING RATIONALE

WCRCL has assigned 'WCRSE 3' (pronounced as WASO Credit Rating Small Enterprise Three) rating under the SME Rating to Hawa Fish Feed and Mathswa Khamar (hereinafter referred as "HFF&MK" or "The Enterprise") based on its financial and other relevant qualitative and quantitative information up-to the date of the rating issuance.
