

### **RATING RATIONALE**

WCRCL has reaffirmed 'WCRSE 3' (pronounced as WASO Credit Rating Small Enterprise Three) rating under the SME Rating to **Tasmi Medical Hall** (hereinafter referred as "TMH" or "The Enterprise") based on its financial and other relevant qualitative and quantitative information upto the date of the rating issuance.
