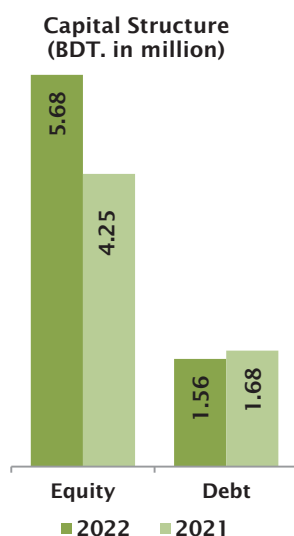

## RATING RATIONALE
