

### **RATING RATIONALE**

WCRCL has assigned 'WCRSME3' (pronounced as WASO Credit Rating Small and Medium Enterprise Three) rating under the SME Rating to M/S Nimai Chandra Paul (hereinafter referred as "NCP" or "The Enterprise") based on its financial and other relevant qualitative and quantitative information up-to the date of the rating issuance.
