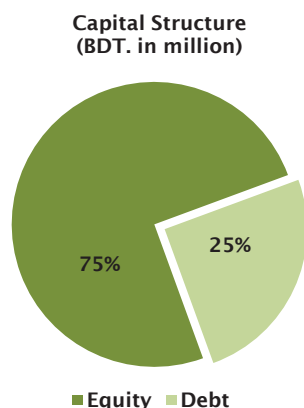

RATING RATIONALE
