

RATING RATIONALE

WCRCL has assigned 'WCRSME3' (pronounced as WASO Credit Rating Small and Medium Enterprise Three) rating under the SME Rating to **Al Abir Traders** (hereinafter referred as "AAT" or "The Enterprise") based on its financial and other relevant qualitative and quantitative information up—to the date of the rating issuance.
