

RATING RATIONALE

WCRCL has reaffirmed 'WCRSME3' (pronounced as WASO Credit Rating Small and Medium Enterprise Three) rating under the SME Rating to Amin Chaul Kall (hereinafter referred as "ACK" or "The Enterprise") based on its financial and other relevant qualitative and quantitative information upto the date of the rating issuance.

The above rating has been assigned based on the fundamentals of the enterprise which includes:

- Long business experiences of the proprietor in the business

However, the above rating has been moderated to some extent due to some factors like:

- Lack of disclosure in the financial statements

- No update trade license
- Manual accounting system
