However, the above rating has been moderated to some extent due to some factors like:

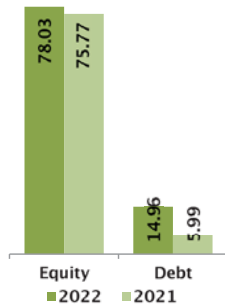
- Low disclosure in the financial statements
