- Good mortgage security coverage against loan

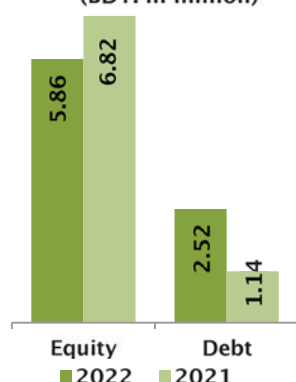
However, the above rating has been moderated to some extent due to some factors like:
